What is the overall <a href="#">deductible</a> ?	<a href="#">Network providers</a> : \$3,000/individual \$6,000/family <a href="#">Out-of-network provider</a> : \$6,000/individual \$12,000/family	Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. The deductible is <b>Non-Embedded</b> . If you have other family members on the plan, the overall family deductible must be met before the plan begins to pay. <b>Deductible year runs 01/01 – 12/31</b>
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive care</a> services are covered before you meet your <a href="#">deductible</a> .	This plan covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. For example, this plan covers certain <a href="#">preventive care</a> without <a href="#">cost-sharing</a> and before you meet your <a href="#">deductible</a> . What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a> ?	<a href="#">Network providers</a> : \$3,000/individual \$6,000/family <a href="#">Out-of-network providers</a> : \$12,000/individual \$24,000/family	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services. The out-of-pocket limit is <b>Non-Embedded</b> . If you have other family members on the plan, the overall family out-of-pocket limit must be met.
What is not included in the <a href="#">out-of-pocket limit</a> ?	<a href="#">Premiums</a> , <a href="#">balance billing</a> charges, and health care this <a href="#">plan</a> doesn't cover.	Even though you pay these expenses, they don't count toward the <a href="#">out-of-pocket limit</a> .
Will you pay less if you use a <a href="#">network provider</a> ?	Yes. **Does this plan provide Minimum Essential Coverage? Yes**
